The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form for Profit Corporation under Section 607 of the Florida Statutes.

#### **ARTICLE 1- NAME**

The Name of the Corporation is WHETSTONE INVESTMENTS, INC. (hereinafter, "Corporation").

#### ARTICLE 2- PURPOSE OF CORPORATION

- 7.4 The Board of Director(s) of the Corporation may, by Restated Articles of Incorporation, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

#### ARTICLE 8- POWERS OF CORPORATION
