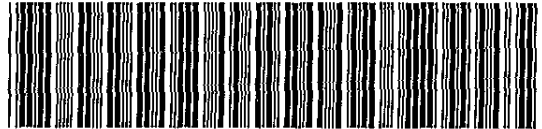

**ARTICLE ONE**

The name of this corporation is OLD FLORIDA TRUST DEVELOPMENT COMPANY and the mailing address of the corporation shall be 4120 SW 20<sup>th</sup> Avenue, Cape Coral, Florida 33914.



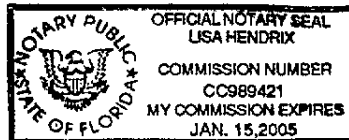


