### ARTICLES OF INCORPORATION

# FRANCIS DUNMYER LANDSCAPING, INC.

## ARTICLE I - NAME:

The name of this corporation is: FRANCIS DUNMYER

LANDSCAPING, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

### ARTICLE III - PURPOSE:
