ARTICLES OF INCORPORATION

SECRETARY OF STATE TALL AHASSEE, FLORIDA

WE THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges an immunities of corporations for profit.

ARTICLE I - NAME

The name of the corporation shall be:

Zebra Trees, Inc.

ARTICLE II - NATURE OF BUSINESS

The general character or nature of the business to be transacted by this corporation is: To engage in any lawful act or activity for which corporations may be organized under the general Corporation law of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is One Hundred (100) Shares of common stock, of Five and 00/100 Dollars (\$5.00) per share.
