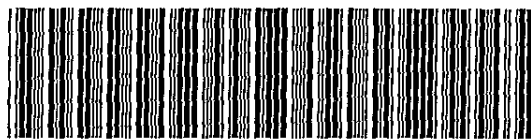



ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is Sunny Ridge Builders, Inc.

ARTICLE III: DURATION

The duration of the corporation is perpetual.

The name and address of the incorporator of these Articles of Incorporation is Bryan S. Belcher, 1619 Pasadena Avenue, Sebring, Florida 33870.


