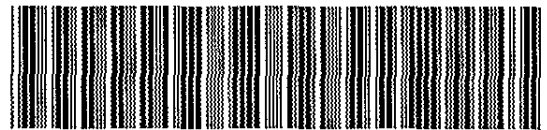



ARTICLES OF INCORPORATION

Gold Coast Investors & Builders Inc.

Article 1. The name of this corporation shall be Gold Coast Investors & Builders, Inc., and the street address of the initial principal office of this professional association shall be 14320 Bristol Bay Place #403, Fort Myers, FL 33912.


Article 4. This corporation is authorized to issue one thousand (1000) shares of \$1.00 par value common stock.
