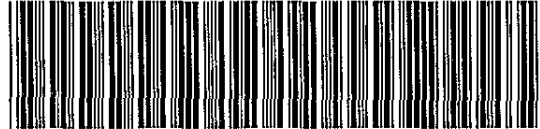

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME:

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The name of this corporation is: MIKE BRIDWELL HOME
REPAIR, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon
the filing of the Articles of Incorporation with the Department
of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in
the Home Repair business and for the purpose of transacting
any or all other lawful business not inconsistent with Laws of
the State of Florida.

ARTICLE IV - CAPITAL STOCK:

The Corporation is authorized to issue 100,000 shares of One
Dollar (\$1.00) par value common stock.

ARTICLE V - PRE-EMPTIVE RIGHTS:

Every shareholder, upon the issuance of any new stock (in-
cluding treasury stock) of the same kind, class or series as that which
he or she already holds, whether for or without consideration, including
but not limited to new stock or treasury stock issued as compensation
to directors, officers, agents or employees, of the corporation or to
satisfy conversion or option rights; shall have the right to purchase
his or her pro-rata share thereof (as nearly as may be done without the
issuance of fractional shares) at the same price at which it is offered
to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT:

The principal office and street address of the Corporation is: 395 Canterbury Circle, Ft. Walton Beach, FL 32548 and the mailing address is: 395 Canterbury Circle, Ft. Walton Beach, FL 32548.

ARTICLE VII - INITIAL BOARD OF DIRECTORS:

The Corporation shall have one director initially. The number of directors may be either increased or decreased from time to time by the By-Laws but shall never be less than one. 
ARTICLE IX - BY-LAWS:
