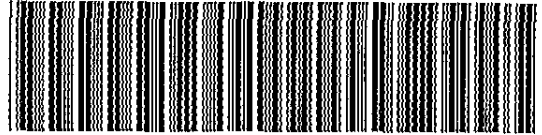

This corporation shall have perpetual existence.

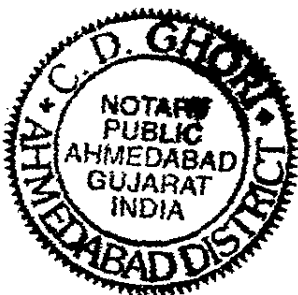
5. **ARTICLE V SHARES**

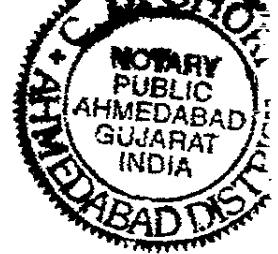

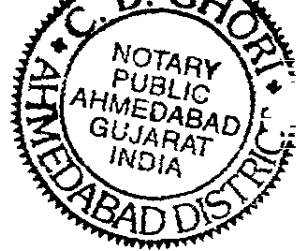
