




RE: Waiver of Reinstatement Fees

Dear Ms. Milligan and The State of Florida, Division of Corporation,

Thank you for speaking with me yesterday about waiving my reinstatement fees. I plead with you and the State of Florida, Division of Corporation to waive our fees as I am a very conscientious person and have always tried to be timely in the filing and paying of government obligations. Federal and State. I am also a very small business and this is an extreme hardship for me as our non-payment for the NSF filing fee for \$150.00 was out of my control.

In September 2004, due to hurricanes, our direct deposits through wire transfers had not posted for over 1 week. During that time, my bank was also closed for two days due to the hurricanes. When I found out that my check of \$150.00 for my firms' annual report did not clear the Division of Corporation, I called your office immediately. I was informed that the check was not showing as 'not being paid or returned' by your office (the representative checked with the accounting department as well), and that the check would be submitted again. I also informed the representative of the situation with regards to the hurricane and our wire transfer deposits not posting.

On September 18, 2004, my firm was Honoree for the Minority New Business Award for the State of Florida in Miami. I went to Miami right after phoning your office. During that time my firm also received a contract in Miami and South Florida to assist with hurricane implementation cleanup, which therefore kept me in Miami until December 30, 2004. During that time our mail had been requested to be forwarded but my mail was unable to get to me due to the hurricanes. And also during that time, I had to leave the State for a very serious family emergency, thus returning back to Miami to complete my contract.

When I returned to Jacksonville, FL on December 30, 2004, I received a notice from the State that my corporation had been dissolved. The NSF check was attached and showed only clearing once, and I had been previously informed that the NSF check would try and clear twice. In any event, I had my CPA, send a letter to your office regarding the same effect I am telling you and I mailed it on December 31, 2004. I called to follow-up on January 5th and found no response and again on January 13th whereas I was told my letter went out from your office on January 11th. I was informed by the representative that my letter was not attached and may have been separated in the mailroom.

To this day, February 4, 2005, I have not received a letter from your office regarding my reinstatement. Therefore, I am providing you another letter and plea to waive our reinstatement penalty fee due to the hurricane and to inform you that I did not receive any notices from your office regarding the NSF check and the cause of the NSF check was due to the hurricanes and consequences stemming from the hurricanes.

Our firm is under consideration for additional contracts and cannot pursue unless our firm is in good standing. I humbly appreciate your assistance.
