ARTICLE I - NAME AND ADDRESS: The name of this corporation shall be SURFSIDE GAMES, Inc., with its mailing address being 800 E. Broward Blvd, Suite 700, Fort Lauderdale FL 33301, and its principal address being 800 E. Broward Blvd, Suite 700, Fort Lauderdale FL 33301.
