ARTICLES OF INCORPORATION

OF

ARTICLE I. CORPORATE NAME.

The name of this Corporation shall be B & B HOME RESTORATION AND REPAIR, INC.
The principal place of business of the corporation shall be 2044 BROKEN ARROW TRAIL NORTH,

ARTICLE II. DURATION.

This Corporation shall have perpetual existence commencing upon filing of these articles.
