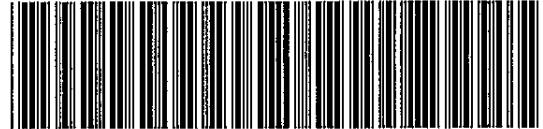

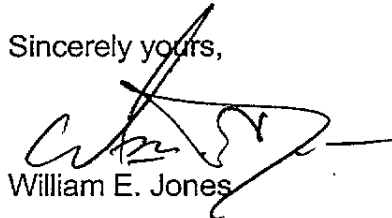

**ARTICLES OF INCORPORATION
OF

ARTICLE I --NAME

The name of this corporation is **BONNY ISON PAINTING, INC.**

ARTICLE II--PRINCIPAL OFFICE

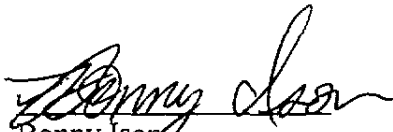
ARTICLE X--INDEMNIFICATION

The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.

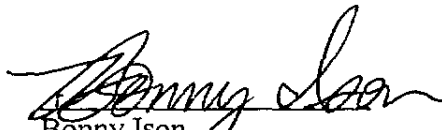
ARTICLE XI--AMENDMENT

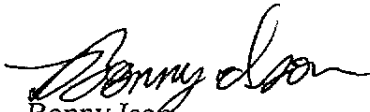
