**ARTICLES OF INCORPORATION
OF
SKIN CARE SPECIALIST, P.A.**

The undersigned sole incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act and the Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is **Skin Care Specialist, P.A.** (the "Corporation").

**ARTICLE II
PURPOSE**

The purpose of the Corporation and the nature of its business are as follows:

1. To engage in the practice of cosmetology and to provide services incident thereto.
2. To do everything necessary, proper or convenient for the accomplishment of such purpose, and to do every other act incidental thereto which is lawfully permitted.

**ARTICLE III
PRINCIPAL OFFICE AND MAILING ADDRESS**

CAPITAL STOCK**

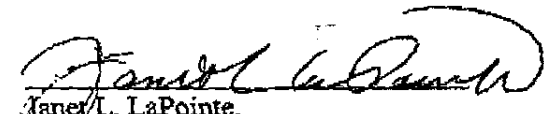

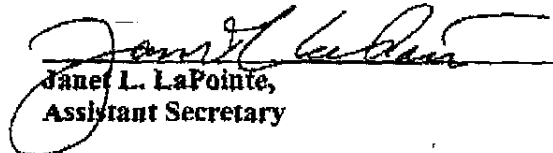
**CERTIFICATE OF ACCEPTANCE BY
