The name of the corporation shall be *Cross Enterprises of Ocala, Inc.*

ARTICLE II PURPOSE

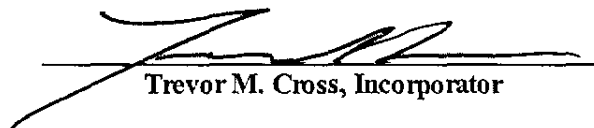

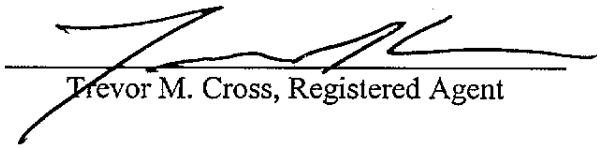
