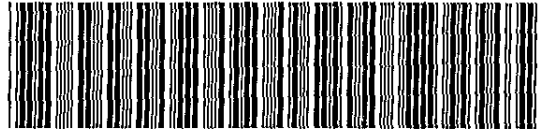

ARTICLE I- NAME AND ADDRESS

The name of this corporation is **AMERICAN GRAPHIC ENTERPRISES, INC.**, with its principal address at 648-3 East Union Street, Jacksonville, Florida 32206.

ARTICLE II- DURATION

This corporation shall exist perpetually.

ARTICLE III- PURPOSE AND POWERS

The general nature of the business to be transacted by this corporation shall be to operate a silk screening t-shirt business and any and all lawful business including, but not limited to manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property and services of every class, kind and description. 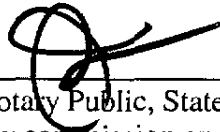

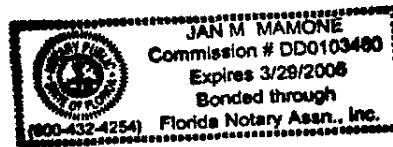
