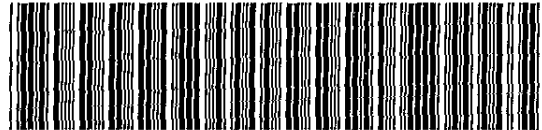

## ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this corporation is Kurley's Enterprises, Inc.

### ARTICLE II - PRINCIPAL OFFICE
