The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

- NATURE OF BUSINESS: The corporation of Services of the corporation of Term of Existence Unlimited. Inc.
- II.
- III. NATURE OF BUSINESS: The corporation may engage in any activ business permitted under the laws of the United States or of the laws pf State of Florida.
- IV. CAPITAL STOCK: The aggregate number of shares of stock that this corporation is authorized to issue is one thousand (1,000) shares. Such shares shall be of single class and shall have a par value of one dollar (\$1.00) per share.
- STOCK TRÂNSFERS CORPORATION'S RIGHT OF FIRST REFUSAL: No shareholder V. shall have the right to sell, assign, pledge, encumber, transfer or otherwise dispose of any of the shares of the corporation without first offering such shares for sale to the corporation at a price to be agreed upon between the offeror and the corporation.
