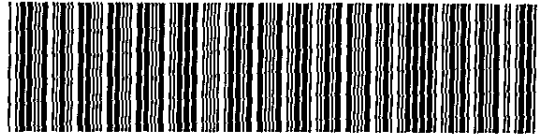

## ARTICLES OF INCORPORATION

OF

### A&R CABINET INSTALLATION, INC.

In compliance with Chapter 607, F.S., Florida Profit

#### ARTICLE ONE

The name of the corporation is A&R CABINET INSTALLATION, INC.

#### ARTICLE TWO

The period of its duration is perpetual.

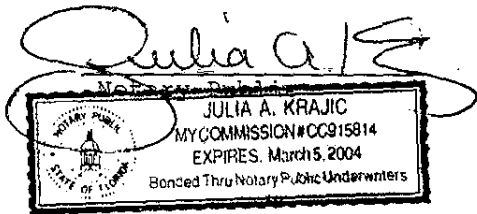
#### ARTICLE EIGHT
