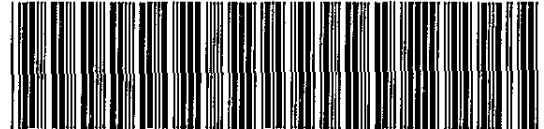

ARTICLES OF INCORPORATION
OF
SOAG MARKETING, INC.

ARTICLE I

The name of this corporation is SOAG MARKETING, INC.



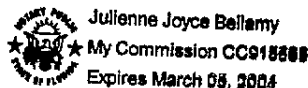
