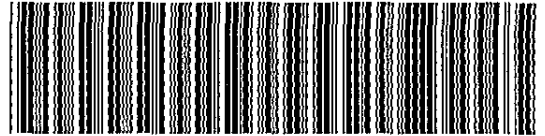

Article I – Name

The name of this corporation is: XPERTECH AUTO REPAIR, INC.

Article II – Duration

This corporation shall have perpetual existence.

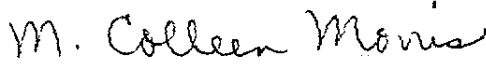
