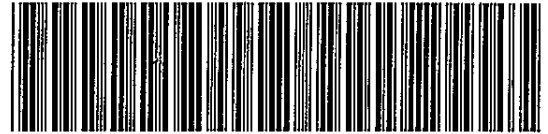

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: MR. C CONCRETE, INC.  
The principal place of business will be 13750 77<sup>TH</sup> Av. North,  
Seminole, FL 33776-3809.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
