## ARTICLES OF INCORPORATION OF P.V. AND ASSOCIATES, INC.

The undersigned, acting as Incorporators of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### Article I - Name

The name of this corporation is P.V. AND ASSOCIATES, INC.

#### Article II - Purpose

This corporation is organized for the purpose of transacting any lawful business.

#### Article III - Principal Office

The street address of the initial principal office is 5051 45<sup>th</sup> Road South, Lake Worth, FL 33463, and the name of the initial registered agent of this corporation at that address is Pradeep Gunness.

#### Article IV-Shared

The aggregate number of shares which this corporation shall have authority to isuee is 1,000 shares of common stock, consisting of one class, and having a par value of \$1.00.

#### Article V - Preemptive Rights
