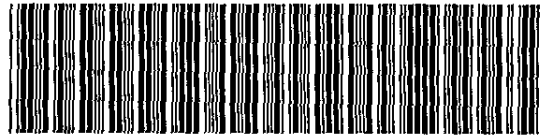

ARTICLE ONE

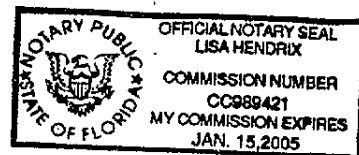
