

# ARTICLES OF INCORPORATION OF

# F.A. Broz, Inc.

# ARTICLE 1. - NAME

The name of the Corporation is F.A. Broz, Inc..

## ARTICLE 2. - PRÍNCIPAL OFFICE

The principal office of the Corporation shall initially be at 451 Beverly Road, Venice, Florida 34293. The Corporation may change its principal office from time to time as permitted by law.
