



# ARTICLES OF INCORPORATION OF FRONTELA IMPORTS, INC.

ARTICLE I-NAME/MAILING ADDRESS. The name of this corporation is: FRONTELA IMPORTS, INC. The corporation's mailing address is: 11920 Sheridan Street, Pembroke Pines, FI 33026.

#### ARTICLE II- DURATION

This corporation is to exist perpetually. It shall commence upon the signing of these Articles of Incorporation by the undersigned subscriber.
