DIRECTORS

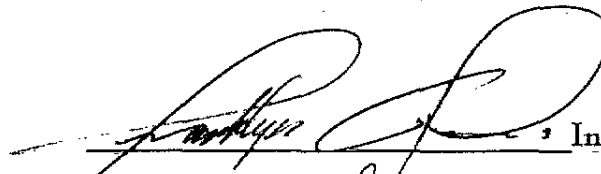

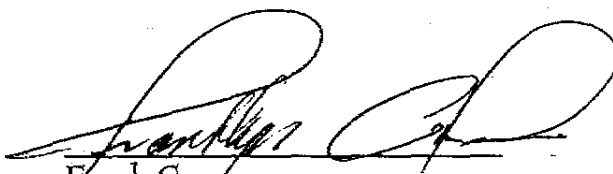
