**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be RICHARD A. WISHAM SURVEYING, INC., with its principal place of business at 11773 South U.S. Highway 441, Belleview, Florida 34420.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States of America, the State of Florida, or any other state, territory, country, or nation.

ARTICLE III - CAPITAL STOCK
