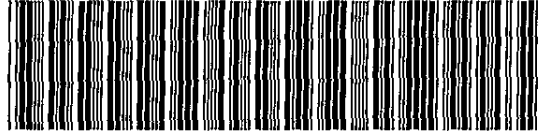

3. This amendment shall become effective upon the filing of the Articles of Amendment with the Secretary of State - State of Florida.

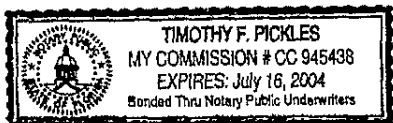


