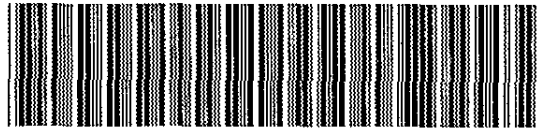

OF




