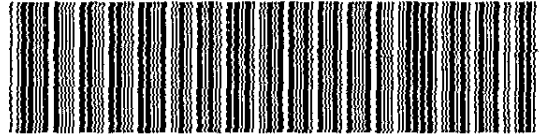

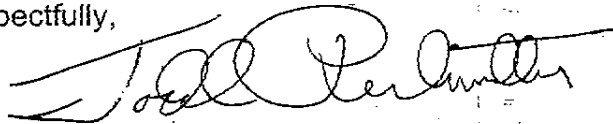

ARTICLES OF INCORPORATION

ARTICLE ONE:

The name of the corporation is: The Electric Connector, Inc.
