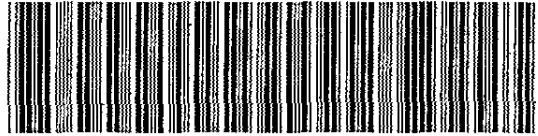

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Riviera Palace Arcade, Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE I - NAME

The name of the corporation is:
