
We are the new accountants for the above referenced Corporation and have received your notice for failure to file their Corporate Annual Report in a timely manner.

We are writing in an effort to have the late filing penalty abated on a one-time basis due to the following. The Corporation was formed on October 27, 2003 and the President Curtis R. Gunderson was operating the corporation without a knowledgeable accountant for the first six months of 2004.
