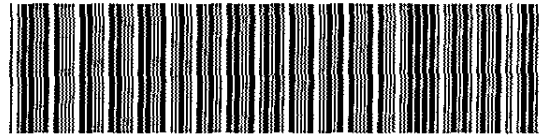

**ARTICLES OF INCORPORATION  
OF  
VANITY CREATIONS CORPORATION**

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

**ARTICLE I**

The name of the Corporation is VANITY CREATIONS CORPORATION ("Corporation")

**ARTICLE II**

The existence of the Corporation shall begin on October 24, 2003

**ARTICLE III**

The street address of the principal office of the Corporation is 2028 NW 21<sup>st</sup> Avenue, Miami, Florida, 33142.

**ARTICLE IV**

The maximum number of shares the Corporation is authorized to issue is One Hundred (100), all of which shall be Common Shares and none of which shall be evidenced by any certificates. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
