ARTICLES OF INCORPORATION

OF

MAZUR'S PAINTING & WALL PAPER, INC.

The Undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is Mazur's Painting & Wall Paper, Inc.

ARTICLE II - NATURE OF BUSINESS
