ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE FLORIDA

The undersigned Subscriber, a natural person competent to contract, desires to form a Corporation under the laws of the State of Florida, and hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of the Corporation is JIM CARTER CONSTRUCTION, INC., and the principal office and address is: 1605 BROOKSIDE CIR. E. JACKSONVILLE, FL 32207.

ARTICLE II. NATURE OF BUSINESS
