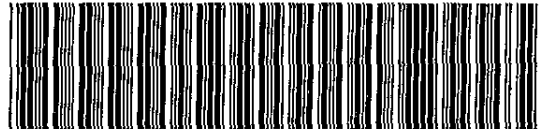



**ARTICLES OF INCORPORATION
OF
JOSEPH H INABINETTE FINISHING, INC**

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be: JOSEPH H INABINETTE FINISHING, INC

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be:

1044 FAIRWOOD LANE JACKSONVILLE, FL 32205

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE IV - PURPOSE



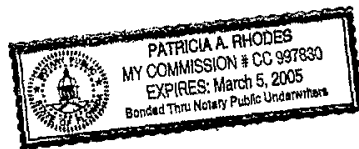


