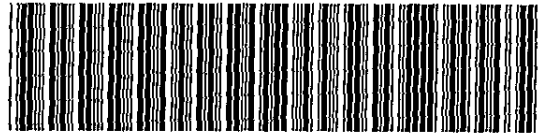

ARTICLE I

The name of the Corporation is Brazell Investments, Inc.

ARTICLE II

Its initial registered office and principal office in the State of Florida is

The name of the initial registered agent at such address is Tracie Brazell.

ARTICLE III

The nature of the business or purposes to be conducted or promoted is to engage
in any lawful act or activity for which corporations may be organized under the
Florida Business Corporation Act.

ARTICLE IV

The total number of shares of capital stock that the Corporation shall have
authority to issue is 1,000 all of which are to be common stock with a par
value of \$.01 per share.

The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than one(1). 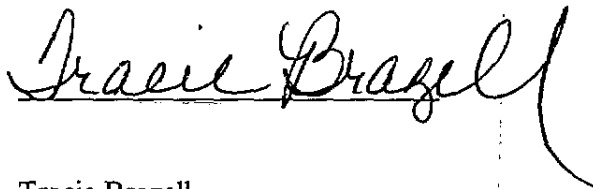
