ARTICLES OF INCORPORATION

-SECKETARY OF STATE TALLAHASSEE, FLORIDA

ARTICLE I - NAME

The name of the corporation is J. Davis Handyman Service of Brevard, Inc., at 1542 Baker Street NE, Palm Bay, FL 32907 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE
