## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF JOE'S MARBLE & TILE, INC.

WHEREAS, the name of the Corporation is Joe's Marble & Tile, Inc.; and

WHEREAS, the Corporation was incorporated pursuant to the provisions of the Florida General Corporation Act, on October 25, 2003 and the assigned document number P03000124788;

WHEREAS, the undersigned Corporation, by and through its Directors and pursuant to the provisions of Section 607.1006 of the Florida Statutes, wishes to amend the aforesaid Articles of Incorporation; and

WHEREAS, the Board of Directors and Shareholders via an action by consent dated as of December 15, 2003, unanimously agreed to amend the aforesaid Articles of Incorporation in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

**1.** Article V – Directors of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

## ARTICLE V DIRECTORS

- a. The initial number of Directors of this Corporation shall be one (1).
- b. The number of Directors may be either increased or diminished from time to time by the Board of Directors or the Shareholders in accordance with the By-Laws of this Corporation. In no event, however, shall the number of Directors be less than one (1).
- c. Nothing in this Article shall be constructed to preclude the Directors from serving the Corporation in any other capacity and receiving compensation therefore.
- d. The name, street address and title of the initial member of the Board of Directors, to hold office until the first annual meeting of the Shareholders of this Corporation or until his successor is elected or appointed and has qualified, is:

- e. Any Director may be removed from office by the holders of a majority of the stock entitled to vote thereon at any annual or special meeting of the Shareholders of this Corporation, for any cause deemed sufficient by such Shareholders.
- f. In case one or more vacancies shall occur in the Board of Directors by reason of death, resignation or otherwise, the vacancies shall be filled by the Shareholders of this corporation at their next annual meeting or at a special meeting called for the purpose of filling such vacancies; provided, however, any vacancy may be filled by the remaining Directors until the Shareholders have acted to fill the vacancy.
- **2.** Except as modified herein, the Articles of Incorporation of said Corporation shall be and remain full force and effect.
