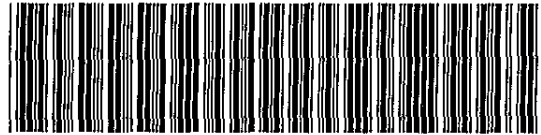

**ARTICLES OF INCORPORATION
FOR SUB S CORPORATION FOR

The undersigned, for the purposes of engaging and organizing a corporation under the laws of the State of Florida, does hereby associate himself and adopt the following Articles of Incorporation for such corporation:

I. **NAME**: The name of the corporation shall be EDWARDS MOBILE HOME SERVICES, INC., and it is to be located at 11455 Pitcairn Street, Brooksville, Hernando County, Florida 34613.

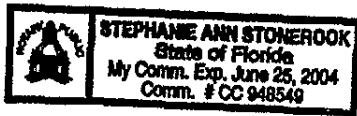
