ARTICLES OF INCORPORATION

OF

TERRY NEELY PAINTING & PRESSURE CLEANING, INC.

BY THESE ARTICLES OF INCORPORARTION the incorporator forms a corporation for profit under Fiorida law.

- 1. NAME. The name of the corporation is Terry Neely Painting & Pressure Cleaning, Inc.
- 2. TERM. The corporation shall exist perpetually. Corporate existence shall begin when these articles are filed with the Department of State.
