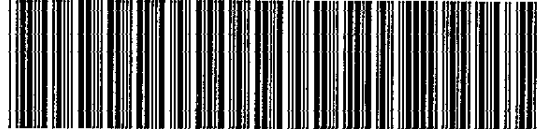

For

**Article I

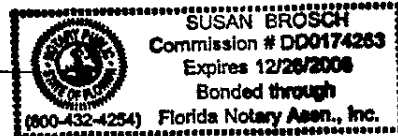
