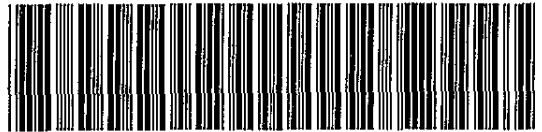

**ARTICLE I - NAME**

The name of this corporation is **EDWARD V. DEUBEL, INC..**


### **ARTICLE X - INDEMNIFICATION**
