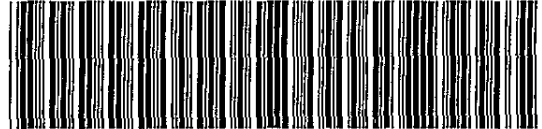

ARTICLES OF INCORPORATION OF
FALCON STAR INTERNATIONAL, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby binds himself to form a corporation under the laws of the State of Florida.

1. **ARTICLE I Name**

The name of the corporation shall be:

FALCON STAR INTERNATIONAL INC.

2. **ARTICLE II PRINCIPAL OFFICE**

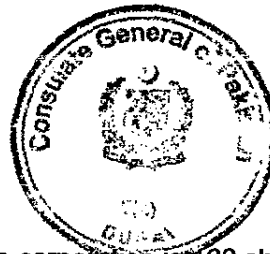

3. **ARTICLE III PURPOSE**

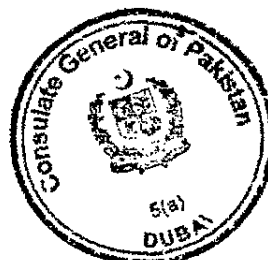



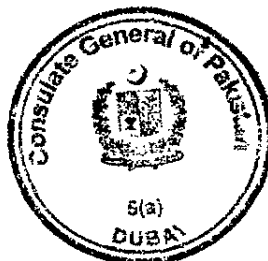
