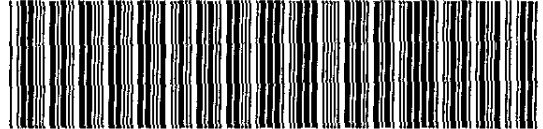

ARTICLES OF INCORPORATION  
OF

(a Florida corporation)

ARTICLE I

Name
