#### ARTICLE 1V - CAPITAL STOCK

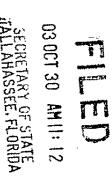
The corporation is authorized to issue One thousand (1000) shares at \$1.00 par value Common stock, which shall be designated "Common Shares".
