In compliance with the provisions of Chapter 607, Florida Statutes, the undersigned, for the purpose of forming a corporation, does hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida, as the Articles of Incorporation of MUNROE PAINTING & DESIGN TEXTURES, INC., a Florida corporation, the following, to wit:

#### **Article I - Corporate Name**

The name of the corporation is as follows:

#### **Article II - Duration**

This corporation shall exist perpetually unless dissolved in accordance with its Bylaws or pursuant to Florida law.

#### **Article III - Purpose**

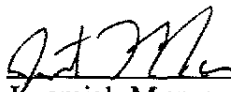

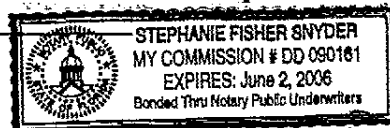

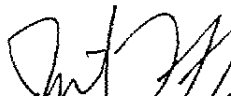
