OF

# INCORPORATION

We, the undersigned, hereby make, subscribe, acknowledges and file these Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

# ARTICLE I

The name of the corporation shall be:

### ARTICLE II


