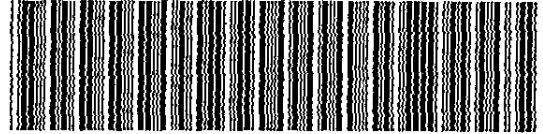

ARTICLE I

The name of this corporation is: **SPECIALTY EXTERIORS, INC.,**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of this corporation is to provide remodeling and construction services for residential structures and any and all other lawful business.

ARTICLE IV - CAPITAL STOCK
