ARTICLES OF INCORPORATION OF CMF Aluminum Specialties, Inc.

ARTICLE I. NAME

The name of this corporation shall be CMF Aluminum Specialties, Inc.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of the corporation's existence shall be at the time of filing of these Articles of Incorporation by the Department of State. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE
